- a. AB 2020-01, Okanogan County Dispatch Services Agreement
 - Due to the passage of Proposition #2, the dispatch services agreement needs to updated to include the new invoicing procedures with Okanogan County Sheriff's Dispatch. The agreement will be effective in 2021. Keith St. Jeor moved with Dale Rey seconding to approve the Okanogan County Dispatch Services Agreement. Motion carried.
- b. AB 2020-02, NCHIP/Livescan Fingerprinting Grant Acceptance.

 Keith St. Jeor moved with Merv Schmidt seconding to accept the grant agreement with Washington State Patrol for the Livescan Fingerprinting system and ratify the Mayor's signing of said agreement. Motion carried.
- c. Colville Tribes Franchise Agreement requirements met.

The Confederated Tribes of the Colville Reservation is asking the Town to sign-off that the requirement to relocate the Town owned fiber from behind the fenced area to the Town's electrical pole on Sixth Street. Superintendent Mike Steffens confirmed that is had been done. Dale Rey asked for a little history in the Town's acquisition of Fiber. Keith St. Jeor provided a brief summary. Dale Rey moved with Merv Schmidt seconding to authorize the Mayor to sign the letter of acknowledgement that the requirements have been met. Motion carried.
