b. Wastewater Treatment Plant Valve Replacement

Superintendent Steffens received an updated quote to replace the valves at the treatment plant from Big Sky Industrial. The council approved the repairs up to \$10,000 last fall but the updated quote came in over \$2,000 higher. Some of the expenses can be reduced by using our own crew for labor. Steffens stated that the issue is becoming more pressing and needs to be repaired as soon as possible. (m/s St. Jeor/Schmidt) to proceed with the repairs for a cost up to \$13,000. Motion carried.
