

Minutes 1428th Regular Council Meeting March 13, 2024

6:00 p.m. Regular Council Meeting

Mayor Poch called the 1428th regular meeting of the Coulee Dam Town Council to order at 6:00 p.m.

Action Agenda

a. Interlocal Agreement for Street Projects

(m/s Schmidt/St. Jeor) to approve the Interlocal Agreement with Electric City and Grand Coulee in substantially the same form and authorize the Mayor to sign the agreement. Motion carried.

b. <u>UDC Codes – Codification and transition to online platform</u>

The Clerk presented two options for transitioning the UDC codes to an online platform. The first option is to codify the UDC codes and keep them as their own separate set of codes and the second option was to incorporate the UDC codes as a new chapter into the Municipal Codes. The council consensus was to incorporate them into the Municipal Codes.

- c. Ordinance No. 818, Repealing Ordinance No. 483 (m/s St. Jeor/Black) to adopt Ordinance No. 818. Motion carried.
- d. Police Department Copy Machine

(m/s Black/Schmidt) to authorize town staff to enter into a new lease agreement for a new copy machine in the Police Department. Motion carried.

e. BPA Energy Efficiency Rebate for STCU Lighting Project

The Clerk notified the council that the town received \$8,340 from BPA for an energy rebate for the lighting project completed by Spokane Teachers Credit Union (STCU). Some discussion took place as to if the full amount should be passed on to STCU or if the Town should keep some of it. The town will also be receiving a performance payment for the project as well, but that figure is unknown at this time. (m/s Black/Schmidt) to disperse the rebate of \$8,340 to STCU and keep the performance payment for the town. Motion carried.

Discussion Agenda

a. Community Town Hall Meeting

Mayor Poch informed the council that the Community Town Hall Meeting has been scheduled for April 27th and will be held in the Coulee Dam Town Hall Ballroom. The Regional Board of Mayors is working on topics and an agenda for the meeting.

b. DNR Tree Grant - Ferry Ave Tree Replacement Project

The Clerk notified the council that the Town was awarded the grant from DNR to replace the trees that were taken out on Ferry Ave. It was asked as to which kind of trees will be planted. That is still to be determined. There will be community meetings with more information as the project progresses.
