Action Agenda

a. Melody Lease

The list of items, including a bill of sale, from the potential tenants has not been received. The tenants were provided a copy of the draft lease a week prior to the council meeting and no comments have been submitted by them at this point. Mervin Schmidt suggested contacting the previous tenant to notify him that the lease was terminated and the Town will take possession of the equipment left on the premises. He also suggested the Town give the proposed new tenants 30 days to provide the requested documents. Keith St. Jeor moved with Mervin Schmidt seconding to table for 30 days unless the requested documents are provided by the tenants. Motion carried.

- b. AB 2019-05, Resolution No. 2019-01, Surplus Police Equipment Police Chief Paul Bowden explained the desire to surplus old firearms. He is requesting to use the surplused firearms as trade-in to purchase new ones with updated features and equipment and better suited for Officer use. Keith St. Jeor moved and Mervin Schmidt seconded to approve Resolution No. 2019-01, surplusing of Police Firearms. Motion carried.
- c. AB 2019-06, Resolution No. 2019-02, Comprehensive Plan Update Public Participation Plan The Clerk provided the draft Public Participation Plan that was prepared by SCJ Alliance to the council. Fred Netzel felt that the Plan was too vague and should contain specific topics and dates of public meetings. Keith St. Jeor moved with Mervin Schmidt seconding to table Resolution No. 2019-02 for further clarification. Motion carried.
