a. Wastewater Treatment Plant Project Update

The Clerk received email correspondence earlier in the day between USDA Rural Development (RD) and Varela Engineering. Rick Rose of RD met with the federal office in regard to the close out of the construction contract with MSI and to see if there is the possibility of additional funding to complete the west side lift station. Rick Rose stated that the meeting went well and was better than he had anticipated. RD is requesting more information from the Town, the Town Attorney and the engineers which Varela Engineering is working on.

Staff, Council & Committee Report

Council

Dale Rey is working with the Tribe to schedule a Public Safety Meeting to include Police, Fire, Ambulance and Animal Control. They are hoping to have something scheduled in about 2 weeks.

Rey asked about the hiring status of the Parks Maintenance Position. Superintendent Mike Steffens stated that 12 applications had been received and he is in the process of reviewing them.

Keith St. Joer would like for the council to resume working on the Animal Ordinance.

Clerk

The Town has been notified that a liquor license renewal has been submitted for Rio Grande and asked the council if there were any objections. Rio Grande's lease with the Town is expiring in July so the Clerk reminded the council that a new lease needs to be negotiated soon.
