Discussion Agenda

a. Shoreline Master Program (SMP) Update

SCJ Alliance Planner Alicia Ayars provided a status update on the SMP noting that there were a couple of things updated in regards to critical areas. The next step in the process is the notice of intent to adopt. The intent to adopt will begin a 60 day review process with the Department of Ecology. With the current schedule, the SMP should be ready for adoption in August. (m/s Rey/Schmidt) to initiate the intent to adopt of the SMP. Motion carried.

b. <u>TIB 6th Street Improvements Project.</u>

The Clerk read a status update provided by TD&H Engineering. The project has reached substantial completion on May 22nd. The final walkthrough identified multiple punch list items that will need to be addressed most of which were related to the concrete work.

c. WSDOT Safe Routes to School Grant

The Town has received notification from WSDOT that the Safe Routes to School that Coulee Dam has been selected to receive funding. The official grant award will be issued in the near future. This is a \$392,886 grant to install flashing school zone and crosswalk beacons in multiple locations along with other improvements and updates to lighting and ADA ramps.

Staff, Council & Committee Report

Council

The Lease Committee, Schmidt and Black, are reviewing the draft lease agreement for the theater. A question they are looking to clarify is what recourse the Town would have if the Lessee doesn't complete the \$200,000 in improvements. They will be scheduling a meeting with the potential Lessees in the near future.

Mayor Poch and Councilman Black attended a meeting with BPA to discuss the Feeder 4 replacement project.

Police

The Officer that has been out on leave for a couple of weeks is returning.

The Annual Financial Report is complete, and copies have been provided to all of the council members. The Clerk thanked the Finance Committee for their quick review and for providing the signed certification form back to her.
