

# Minutes 1363<sup>rd</sup> Regular Council Meeting October 14, 2020 (TELECONFERENCE)

6:00 p.m. Regular Council Meeting

Mayor Bob Poch called the 1363<sup>rd</sup> regular meeting of the Coulee Dam Town Council to order at 6:01p.m. via teleconference.

Councilman Fred Netzel requested discussion time regarding the Animal Control Ordinance.

## **Action Agenda**

a. <u>AB 2020-14, Ordinance No. 788, Budget Amendment</u>
Keith St. Jeor moved and Mervin Schmidt seconded to adopt Ordinance No.788, amending the 2020 budget. Motion carried.

# b. AB 2020-15, Resolution No. 2020-04, Surplus Ambulance

Dale Rey asked if the council will ever want to re-start the ambulance service. Grand Coulee is currently providing ambulance service to the Town of Coulee Dam. Councilmen Rey and Netzel questioned if the town had a formal written agreement for Grand Coulee to provide ambulance services with the assumption that such an agreement didn't exist. Councilman St. Jeor and the Clerk stated that there is a written agreement in place. Keith St. Jeor moved with Dale Rey seconding to approve Resolution No. 2020-04, declaring the ambulance as surplus. Motion carried.

## c. <u>Garvin Coffee Stand – Pre-Application</u>

Before Mayor Poch began discussion on the topic, Councilmen Rey reminded the council that he has formally recused himself from any involvement of the topic. Mayor Poch briefly reviewed the application that was received to place a coffee stand on Town-owned property and asked the council to review the two letters that were submitted from the Police Chief and the Risk Manager of the Town's insurance provider. Applicant Kasey Garvin joined into the conversation wanting to address the concerns that the Police Chief had. Garvin also told the Mayor that she was told by the Clerk that the pre-application process would not be taken to council as it was an administrative process. The Clerk explained that due to some unusual circumstances affecting the application, the Mayor felt like the council needed to be involved.

Discussion was held on the potential pedestrian and traffic safety hazards, parking issues, and sewer connections at the proposed site. The insurance provider is recommending a formal engineered traffic study be conducted at the location. Garvin stated that she has met with the Public Works Superintendent, Mike Steffens regarding the sewer connection issue. She is proposing a gray water catchment system.

The council would like more information regarding the traffic study before approving the application. The Clerk will contact the Risk Manager for recommendations of an engineer.

#### **Discussion Agenda**

#### a. Animal Control Ordinance

Fred Netzel and Dale Rey have been working on the cat section of the ordinance and asked the council where they would like to go from there. Mayor Poch stated that the dog ordinance is currently in the attorney's hands for review and suggested it be put on hold until after the attorney's review. Keith St. Jeor has some comments regarding potentially dangerous and dangerous dogs and following RCW. Animal license fees were also briefly discussed.

#### b. Comprehensive Plan Update

The Clerk gave a brief update on the status of the plan. The Planners are actively working on the council's requested changes and should be able to provide the updated draft plan soon.
