2001 FEE ADJUSTMENT ADDENDUM TO JAIL
SERVICES AGREEMENT**

This Addendum is entered into this January 1, 2001, by and between the Okanogan County Sheriff's Office (OCSO) and the Town of Coulee Dam, pursuant to the Interlocal Cooperation Act, chapter 39.34 RCW. It is hereto hereby expressly acknowledged and understood that this addendum is intended to adjust the fees set forth in the previously existing Jail Services Agreement between the parties.

The Town of Coulee Dam agrees to make payment to the OCSO for each and every prisoner arrested and booked by the Town of Coulee Dam, who the Prosecutor, either by information or citation; or by a grand jury indictment, initially charges with a misdemeanor. The initial charge shall be determinative as to whether the offense is a misdemeanor or felony for the purposes of the applicability of payment. Amendment, changing the level of the crime charged, shall not have the effect of incurring or excusing payment. The Town of Coulee Dam agrees to make payment as follows:

1. For all prisoners, the Town of Coulee Dam shall pay a flat rate of Twenty Dollars and Eighty-one Cents (\$20.81) per prisoner, as compensation for booking expenses.
2. For any prisoner who is detained in excess of six (6) hours, the Town of Coulee Dam shall make additional payment in the amount of Forty-three Dollars and Ninety-seven Cents (\$43.97) per day, but such charge will be prorated on an hourly basis for any part of a day after the first day, beginning at the time of booking up to the date of court arraignment or release.
3. These rates will be in effect from January 1, 2001, until contract termination or as amended with the understanding that each calendar year any increase in fees will be based upon the cost of living as reported by U.S. Department of Labor, Bureau of Labor Statistics in the October Consumer Price Index (CPI) report.
